David R. Thomas

David R. Thomas is going on his 35th year of providing training and technical assistance to law enforcement at the state, local, national, and international levels. He is a retired police officer who taught at Johns Hopkins University, served the Air Force Sexual Assault Prevention and Response Program as a Highly Qualified Expert before working in his present position as a Program Manager II, International Association of Chiefs Police.



Johanna Niemi

Niemi is the Professor of procedural law at University of Turku, and the Minna Canth Academy professor 2015-2019. She has researched and led research projects on different aspects of violence against women and the criminal process, including rape, domestic violence, protection orders and sex-buying. Her recent work includes Niemi et al. (eds), International Law and Violence against Women: Europe and the Istanbul Convention. Routledge 2020.



Raija Toiviainen

Toiviainen, Master of Laws, is the Prosecutor General of Finland. She started at the Office of the Prosecutor General in 1997 and has since served as State Prosecutor and Head of the International Unit.

Toiviainen was appointed Deputy Prosecutor General in 2016, and later served as temporary Prosecutor General.



Julia Korkman

Adjunct professor Julia Korkman is co-leading the research group in legal psychology at Åbo Akademi University; [LePÅ](#). Dr Korkman delivers expert training in legal psychology and lectures to professionals in various fields, e.g. the legal system and police, conducts investigative interviews in criminal investigations, and is responsible for the first national [Specialisation course in Forensic Psychology](#). She is particularly interested in investigative interviewing and memory within the legal context. Furthermore, Dr Korkman is a certified expert of the [Justice Rapid Response](#) roster since 2021, and also the President-elect of the European Association of Psychology and Law.



Silvia Antoaneta Berbec

Berbec is the President of Pro Refugiu Association and lawyer in the Bucharest Bar. She is specialised in Criminal Law, Public International Law, Human Rights and Humanitarian Law. Over the years she has been actively involved in actions that can enhance access to justice for vulnerable individuals with a focus on asylum seekers, refugees, victims of gender-based violence, victims of human trafficking, victims of hate crime, racism and xenophobia.



Dr Maria Yordanova

Dr Maria Yordanova joined the CSD in the late 1998 and has since directed the CSD Law Program. Previously, she was Assistant Professor of Comparative Constitutional Law and Systems at the University of National and World Economy in Sofia and senior legal advisor at the United Bulgarian Bank Ltd.
